### **University of Dundee - Annual Procurement Report (APR)**

#### **Executive Summary**

The Procurement Reform (Scotland) Act 2014 (PRA) required any public organisation which has an estimated annual regulated spend of £5 million or more to develop a procurement strategy and then review it annually. This requirement took effect from 31 December 2016.

Organisations (including HE and FE institutions) required to develop and publish a procurement strategy were also required to publish an APR, reflecting on the relevant reporting period of the procurement strategy.

This report covers the period of 1<sup>st</sup> August 2020 to 31<sup>st</sup> July 2021 and addresses performance and achievements in delivering the <u>University of Dundee's procurement strategy</u>.

The development of the procurement strategy was the outcome of consultation and discussion with internal and external stakeholders who have an interest in the institutional approach to procurement and its impact. Stakeholder engagement will also feature in the annual assessments of the achievement of regulatory compliance, strategic objectives of the institution, value for money [defined as the best balance of cost, quality and sustainability] and delivery against the institution's broader aims and objectives, in line with <a href="Scotland's National Outcomes">Scotland's National Outcomes</a>. This process of review and reporting will inform any adjustments to the procurement strategy deemed necessary to secure future performance improvements and to respond to the economic, political and financial influences to which the institution may need to adjust.

The University of Dundee has analysed third party expenditure and has identified that over the period covered by this report the following expenditure has occurred:

- The total procurement expenditure was £81,434,013.49
- There were 3263 active suppliers on the purchasing system at the end of the reporting period.

In summary the University of Dundee concluded the following compliant regulated procurements over the reporting period:

- EU regulated procurements [goods and services worth more than £189,330; works worth more than £4,733,252<sup>2</sup>] amounted to £1,187,114. There were 3 such procurements completed<sup>3</sup>.
- Lower value regulated procurements' [goods and services worth more than £50,000, works worth more than £2 million] amounted to £1,306,441. There were 15 such procurements completed.

More detailed information on the regulated procurements, sorted into procurement categories, is provided in Sections 1 and 2 and in Appendix A of this report.

The University has been optimising use of national, sectoral, local or regional C1 collaborative contracts and frameworks. As well as bringing leverage based savings, the burdens of risk,

contract and supplier management are shared and the number of resource-intensive formal local tenders that need to take place is reduced significantly. XX% of the University spend went through collaborative agreements.

#### **Section 1: Summary of Regulated Procurements Completed**

The University of Dundee strongly believes in conducting its procurements in an open and inclusive manner with procurement objectives aligned to the University's Strategic Plan.

The details of regulated procurements completed are set out in a list at the end of this report with details summarised in Appendix A. That information, coupled with the publication of the institutional <a href="Contracts Register">Contracts Register</a> and the systematic use of Public Contracts Scotland and Quick Quotes, provides complete visibility of the University's procurement activity over the reporting period.

In Appendix A, information is set out to show lower value regulated procurements completed and EU regulated procurements completed. These are separated into contract categories and distinguish collaborative contracts from institutional ones. For each completed regulated procurement the information provided shows:

- the date of award
- the start dates
- the category subject matter
- the name of the supplier
- estimated value of the contract total over contract period
- collaborative or institution owned
- the end date provided for in the contract or a description of the circumstances in which the contract will end.

#### **Section 2: Review of Regulated Procurement Compliance**

Where appropriate, the University of Dundee has made use of collaborative contracts to deliver improved contract terms, supported contract and supplier management, sustainable procurement outcomes and value for money (the best balance of cost, quality and sustainability).

In making its regulated procurements every care has been taken to ensure that the University awards the business to suppliers who are capable, reliable and who can demonstrate that they meet high ethical standards and values in the conduct of their business.

In the period covered by this report the University has conducted all its regulated procurements in compliance with EU Treaty Principles of equal treatment, non-discrimination, transparency, proportionality and mutual recognition.

Successful delivery against the procurement strategy objectives is part of a customer valued, continual improvement process (CIP) that seeks incremental improvements to process and outcomes over time.

management. Progress in this area has been limited due to resource availability and supporting the University through the COVID-19 pandemic.

Embed ethical, social and environmental policies within the University's procurement function to ensure compliance with relevant Scottish, UK and EU legislation in performance of the sustainable procurement duty.

All suppliers are required to agree to the <u>Sustain Supply Chain Code of Conduct</u>. The code requires suppliers to operate in an environmentally, socially, ethically and economically responsible manner and covers specific areas such as employee working conditions, the eradication of corruption and bribery in the supply chain as well as ensuring the supplier's operations have minimal impact on the environment.

The University is required to declare the SME status of all contracted suppliers when updating the Contract Register.

Contract strategies are produced for all contracts above the Regulated threshold capturing information on key sustainability indicators including Community Benefits clauses and contracts awarded to Supported Businesses where appropriate.

The University's Modern Slavery Statement has been updated with the progress made during the relevant reporting period and is available from the front page of the University's website.

Sustain and further develop partnerships within the sector, with other publicly funded and professional bodies, and appropriately with supply markets that will yield intelligence, innovation and deliver value to users of procurement.

Collaboration with Institutions and other publicly funded bodies is explored as part of the contract strategy for each contract let by Procurement. The University shares information periodically with APUC members and with TOPiC (Tayside Opportunity Procurement in Collaboration) to identify any potential collaborations, share best practice and market intelligence.

The implementation of Category Management is being used as an enabler to move the University in the direction of longer-term strategic rather than shorter-term transactional relationships with our suppliers. By identifying our key strategic suppliers, the University will be able to engage with them in order to leverage innovative solutions to complex requirements and take advantage of best practice approaches.

Early market engagement is used regularly by Procurement as both a strategic exercise in developing supply markets and for refining our specification and requirements documentation prior to formal market approaches.

The University of Dundee has procurement process and sign off arrangements that are consistent with the guidelines set out in the Procurement Journey and that have met the objectives and obligations set out immediately above.

#### **Section 3: Community Benefit Summary**

For every procurement over £4m, the University of Dundee will consider how it can improve the economic, social or environmental wellbeing of its area through inclusion of community benefit clauses, to assist with achieving sustainability in contracts activity, including targeted recruitment and training, small business and social enterprise development and community engagement. Where possible, relevant and proportionate, and where they are considered not to have a negative impact on the delivery of value for money, such clauses may be included in regulated procurements valued at below £4m.

The general University policy on identifying community benefit requirements is to conduct risk and opportunities assessments through stakeholder consultation and engagement – on a case-by-case basis the question is asked, 'could a community benefit clause be usefully included'? Where relevant and proportionate to the subject matter of the procurement, the requirement is then built into the procurement specification and into the eventual conditions of contract performance.

Where applicable, as part of the tendering process, suppliers are invited to describe their approach to delivering community benefits or achieving social value through a contract. Relevant community benefits are cited such as:

- providing 'upskilling' opportunities (e.g. Toolbox talks) with students and staff,
- offering advice and assistance on the best practice methodology,
- employment, student work experience and vocational training opportunities,
- apprenticeships,
- local subcontractor opportunities available to SMEs, 3rd sector and supported businesses,
- direct involvement in community based schemes or programmes,
- equality and diversity initiatives,
- supply-chain development activity,
- educational support initiatives,
- to minimise negative environmental impacts, for example impacts associated with vehicle movements and/or associated emissions and impacts on protected areas, buildings or sites.

Tenderers are invited to describe how such benefits will be successfully delivered through the contract and promoted to contract users. Where community benefits are included in a procurement (at or above the £4 million threshold), the award notice would include a statement of the benefits that are expected to be derived from the contract.

The University of Dundee has awarded 68 contracts over the regulated procurement threshold during the reporting period. Two of these were over £4 million in value and the total number of contracts with community benefit opportunities identified was zero. However, a project commenced in July 2021 to identify lower value contracts where Community Benefits could be obtained. This work also involves the idenitification of Framework Agreements awarded by cosortia where Community Benefits are made available to orgnisations ustilising the framework. It is anticipated the benefits obtained through this project will be reported in the 2021/22 Annual Procurement Report.

#### **Section 4: Supported Business**

Higher value procurements, regulated procurements (between £50k and OJEU threshold and those equal to and above the OJEU thresholds) are conducted in line with Routes 2 and 3 respectively of the Procurement Journey. Both Routes 2 and 3 mandate the use of the European Single Procurement Document (ESPD (Scotland)). The ESPD covers exclusion, selection and award criteria and includes questions relating to companies self-certifying themselves in terms of size (micro, small or medium), or whether they are supported businesses.

As part of the Contract Strategy process, the institution reviews each procurement to determine whether it could be fulfilled by a Supported Business, whilst remaining compliant with EU and Scottish Procurement Legislation and ensuring value for money for the institution (using the only Supported Business <u>register</u> currently available and published by Ready for Business).

Following a presentation to Member Institutions of APUC by one of the Supported Businesses on the Scottish Government Framework Agreement, Procurement initiated contact with Dovetail Enterprises in Dundee. Discussion regarding the possible award of a furniture-related contract continued beyond the reporting period covered by this report, therefore the results of these discussion will be reported in the 2021/22 Annual Procurement Report.

#### **Section 5 – Future Regulated Procurements**

The University of Dundee is keen to encourage competition by promoting optimal participation in its procurement process and achieve better value for money in its procurements. One method of achieving this is to give notice to suppliers of tendering opportunities that are expected to commence over the next two financial years after the period covered by this report.

In preparing a forward projection of anticipated regulated procurements, it is difficult to be precise given the University's varied requirements and the transactional nature of many of our relationships with external parties.

Information relating to future requirements is improving as the Category Management approach is implemented and embedded across the University, however it is anticipated several categories of spend will require some form of procurement activity over the next two years.

Specifically, the University will require to address its travel-related services and multi-function devices requirements. These requirements appeared in the 2019 and 2020 Annual Procurement Report but were not addressed during the 2021 reporting period due to the potential impact of COVID-19 on both the market as well as the University's requirement. Suppliers are encouraged to review the University's contact register to anticipate any upcoming opportunities. A list of regulated term contracts expiring in the next two years is included at Annex B, COVID-19 and resources allowing, we would anticipate a re-tender of each of these requirements in that period.
