Application Process	The University Admissions team will automatically assess your personal information to confirm your eligibility for this award and all eligible offer holders will be provided with further information and instructions on how to apply.  This verification process will be provided effor stage.
Who is eligible?	<ul> <li>This verification process will happen at the initial offer stage.</li> <li>1. All undergraduate students.</li> </ul>
who is engible:	<ul> <li>2. Studying one of these undergraduate programmes (full time):</li> <li>Dentistry BDS, or</li> <li>Medicine MBChB.</li> </ul>
Award Information	<ol> <li>The value of this bursary is £2,000 for Year 1, 2 and 3.</li> <li>The value increases to £2,500 for Years 4 and 5.</li> <li>The payment is made each semester directly by the Medicine or Dentistry Office.</li> <li>Payment of £1,000 per semester is made after matriculation at the University of Dundee.</li> <li>All payment forms provided by the Medicine or Dentistry Office must be completed within the given timeline. Failure to complete the forms by the deadline may mean the student is no longer eligible to receive the bursary. The student does not have to re-apply annually.</li> </ol>

	The bursary will also be suspended for periods of leave of absence that cover part of the academic year and will be reinstated on return to full-time study. On return to study, the student will be entitled to the balance of the bursary for the level.
