

## **University of Dundee Scholarship**

The International College Dundee Progressing with Excellence Scholarship 2025/6 ("the Scholarship")

## **Key Facts Document**

This Key Facts Document sets out the main details of the Scholarship, as at date of publication. This document should be reviewed alongside the <u>University of Dundee Scholarship and Bursary Terms and Conditions</u>, as those terms and conditions will provide you with additional information that apply to you in respect of the Scholarship. If there is any inconsistency between this Key Facts Document and the University of Dundee Scholarship and Bursary Terms and Conditions, the provisions of the Scholarship and Bursary Terms and Conditions will prevail.

Date of publication	October 2024, applicable for students entering ICD in the 2025/6 academic year.
Application Process	There is no separate application form for the ICD Progressing with Excellence Scholarship.
	Your eligibility will be determined by the Academic team at the International College Dundee who will assess your academic performance during your time studying at the College and confirm whether you have met the eligibility criteria.
Who is eligible?	You must:
	Be classified by the University of Dundee and Oxford International Education Group (OIEG) as an International Fee-paying student.
	2. Have completed an ICD full time programme (online or on campus), AND progress to a full time (180 credits, 12 months for TPG; 120 credits per year, 3-4 years for UG), on campus UoD programme.
	3. Have achieved one of the following during the study of their full programme at ICD:
	<ul> <li>a. Overall, achieve an 'A' grade average in their academic performance.</li> <li>b. Show a significant uplift in academic performance during their time at ICD and achieve excellence ('A' grade average) academic performance in the final term.</li> </ul>
	4. Not be studying a PhD Programme.
	5. Have a programme tuition fee of £21,600.
	Please note: Any programme which does not have a fee of this value, or above, will not be considered for this award.



## Scholarship Information

The value of this scholarship is £5,000 and is awarded as a tuition fee waiver to the UoD fees once the student has progressed from ICD to their chosen UoD programme.

- 1. It is not possible to be awarded a Vice-Chancellor's Scholarship or the Global Citizenship Scholarship alongside the ICD Progressing with Excellence Scholarship. You can receive only one of these Scholarships at any one time.
- 2. All scholarships are paid as a tuition fee waiver. No direct payment is made to you.
- 3. The scholarship is paid in each year of applicable study:
  - a. Students on a pathway programme leading to a UoD undergraduate programme can receive the scholarship for up to 5 years of progressing study (maximum of £25,000 over 5 years).

- b. Where the programme is a 3.5-year Undergraduate Degree (School of Business) then the scholarship will only be applied in Year 2 onwards.
- c. Students on as pathway programme leading to a UoD Postgraduate Taught Programme where the programme of study spans more than 12 months full time, and a full year tuition fee is due in each academic year, then the scholarship can be applied in both years of study.
- 4. Scholarships are awarded on an Unconditional basis. However, this is not linked to the programme application status.
- 5. Scholarships cannot be awarded on a pro-rata basis.



## **Key Information**

- 1. You are unable to combine the ICD Progressing with Excellence scholarship with any other University of Dundee scholarship, except for the following:
  - Alumni Scholarship
  - Community Scholarship
    - a. If you are eligible for two scholarships, they can be combined to a maximum of £8,000.
    - b. If you have an externally funded scholarship that covers part of the full tuition fee, this can be awarded alongside one or more University of Dundee scholarships (provided that the total of the awards combined does not exceed the total University of Dundee tuition fee).
    - c. If you have a fully funded external scholarship, the ICD Progressing with Excellence Scholarship will be removed as all tuition fees are covered. The University will not provide ICD Progressing with Excellence Scholarship as an additional award.
- 2. If a student has funding as part of a partnership agreement, then they cannot hold an ICD Progressing with Excellence Scholarship in addition to this. The higher value award will apply.
- 3. Should you wish to defer their entry to the University of Dundee, the following rules apply:
  - a. Deferral within the same academic year: Scholarship can be deferred.
  - b. Deferral to a **new** academic year: Scholarship **cannot** be deferred.
- 4. The scholarship will be suspended for periods of leave / absence. The scholarship will be reinstated on your return to full time study from the point on which your period of study was suspended. For the avoidance of any doubt, the maximum amount that can be paid under this bursary is £25,000.
- 5. Changes to the programme of study:
  - a. If, when you progress from ICD to the University of Dundee, you change programme before/ during matriculation or after latest start date, the University of Dundee reserves the right to re-assess eligibility for scholarships and <a href="mailto:may">may</a> withdraw the Scholarship Offer should your eligibility have changed.
  - b. If you change Fee status or any other personal information before, during or after matriculation, the University of Dundee reserves the right to re-assess eligibility for scholarships and <u>may withdraw the Scholarship Offer</u> should your eligibility have changed.



- 6. The University of Dundee will not back date any awards and all awards made will be current and apply to the student in the current academic year. The University of Dundee will not offer a scholarship to students who have matriculated at the University onto the programme of study.
- 7. If a student re-sits a year of study at the University, the scholarship award will not apply, however will commence once they have progressed to the next level.
- 8. If you have paid your tuition fees in full prior to being awarded the ICD Progressing with Excellence Scholarship, the value of the scholarship will be refunded to you after you have enrolled at the University of Dundee. Alternatively, this can be transferred to your University accommodation account balance (if applicable).
- 9. The scholarship is only paid in the years in which full tuition fees are paid. This applies to applicants who may study abroad during their Undergraduate studies. The University of Dundee will confirm the status of the scholarship where required.
- 10. All communication with you will be via email, to your @dundee.ac.uk email address. We may also communicate with other email addresses provided to us by you or alternatively via the online applicant portal. Types of communication may be:
  - a. Confirming the scholarship.
  - b. Informing you that you have not met the criteria to be awarded the scholarship.
  - c. Requesting further information.
- 11. The University of Dundee is unable to disclose details of the scholarship to anyone other than you unless you provide your consent to do so.
- 12. Should you withdraw from your programme of study, the University of Dundee may be in contact regarding payment of fees and scholarship balance.
- 13. All scholarship and bursary decisions are final and cannot be appealed.
- 14. All scholarships are awarded and administered in accordance with University policies and procedures.
- 15. All scholarships are subjected to the University's scholarship terms and conditions. These are subject to revision from time to time.
